## Where & when

The 5k run starts at 9:00 am at the old Warren County Middle School on 15th Street in Front Royal, Virginia. Race day registration and check-in begin at 8:00 am.

## Course

A measured 5k (3.1 mile) route on paved roads through the northwestern part of Front Royal and the grounds of Randolph-Macon Academy. Mile 1 is downhill to flat; mile 2 is mostly uphill; and the final 1.1 miles are rolling.

## Awards

For the top three men & women overall, the top Masters (40 & over) man & woman, and the top three in the following age groups: 14 & under, 15-19, 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, and 60 & over.

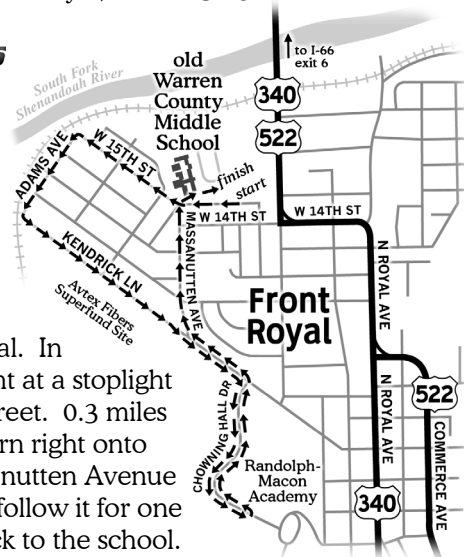

## Directions

The old Warren County Middle School is at 500 West 15th Street in Front Royal. Take I-66 to exit 6 (Routes 340/522) and head south toward Front Royal. In 1.9 miles, turn right at a stoplight onto West 14th Street. 0.3 miles later, turn right onto Massanutten Avenue and follow it for one block to the school. Turn right onto West 15th Street and park in the school lot on your left.
